



Friends of the Forest Preserves works to preserve, protect, and restore the Cook County Forest Preserves for the benefit of people and nature. For this project, you'll work with a representative from Friends of the Forest Preserves to find a local preserve where you and your project team can volunteer. To make this a C3 project, you'll need to volunteer three times at a site/s and involve a project team of at least two people. Please note, many work sites have only one workday per month so plan ahead and choose multiple work sites if necessary.

After completing your C3 project, you can train with a Steward to learn more and eventually become a Steward of your own site. An existing Steward can mentor you on how to restore health to our forests, prairies, and wetlands. On the ground skills include the ability to identify and remove invasive plants, collect native seeds, and burn brush piles. Additional skills offered in the Chicago region that are handy for stewardship work include an herbicide license and prescribed fire training.

## **Timeline:**

**Project Proposal due online:** 2 weeks after the Community Organizing class

**Part I: Contact the Friends' representative and choose your site:** 2 weeks

**Part II: Begin site visits and tracking environmental benefits:** 3 months

**Part III: Final Report due online:** 1 week after your last visit

**Part IV: Follow up (optional):** Continue restoration work at the site. Learn additional skills from the Steward and perhaps become a site steward in the future.

## **Materials:**

- Trash bags to collect waste
- Blue bags to collect recyclables
- Canvas work gloves
- Disposable gloves
- **\$800 Savings Challenge** cards

## **Part I: Contact the Friends' Representative and Choose Your Site**

**~2 weeks**

Your liaison will put you in touch with Alice Brandon at Friends of the Forest Preserves (312-356-9990, [alice@fotfp.org](mailto:alice@fotfp.org)). Alice will help you choose a forest preserve site for you and your project team. She can also give you a better idea of what stewardship work entails and what to bring to your first workday.

## **Part II: Tracking Environmental Benefits**

**~2 months**

Once you begin your site visits, make sure you record and calculate your project's environmental benefits. This could include number of site visits, hours of work, number of community members involved, and outreach you did around your site visits. The most effective measure for documenting the work is to take before and after pictures.

## **Part III: Turn in Final Report (within 2 weeks of project completion)**

**After you've completed your 3 site visits:** As soon as you've calculated environmental benefits, please fill out your Final Report online. Corresponding materials such as digital photographs, posters, press releases, or news clippings should be emailed to [conservation@cityofchicago.org](mailto:conservation@cityofchicago.org). ## **Part IV: Continued Site Visits (Optional)**

After your site visits are complete, we hope you will continue long after you graduate from C3. We also hope you will consider being trained as a full site Steward – think of the impact you could have!
